Rescinding the breeding agreement requires the consent of both the Seller and Buyer. If this puppy is bred without the seller's discretion, there will be a breach of contract and agrees to pay damages to the seller. If the Seller sees i,e, social media, newspaper, website, marketplace, or any other selling platform and/or hear that the buyer is breeding without the consent and knowing to the seller, the ownership of the puppy is transferable to the seller for breach of contract.*

The breeder has stated the socialization process, the purchaser's responsibility that the puppy is raised and properly socialized, obedience class and efforts must be made to ensure the continued development of proper behaviour.

**Life threatening diagnosis**

If the puppy exhibits a life-threatening or severe life-altering condition which would cause the puppy to be euthanized and is the result to a genetic defect, breeder will respond:

- Purchaser must notify breeder within 24 hours of a vet diagnosis or this contract is voided.
- Vet records documenting the condition of the puppy must be provided by the purchaser's expense. [bosscrowbullies@hotmail.com](mailto:bosscrowbullies@hotmail.com)
- The breeder may require an examination by a vet, chosen by the breeder.
- In the case the animal is already deceased, the breeder will require that a complete autopsy be performed to gain the cause of death. Documentation must be forwarded to the breeder at the purchaser's expense.
- Before euthanasia is administered the breeder must be consulted on the contract is voided.

**Litter agreements**

Before any said litters comes into effect; payable puppy fee must be made in full to Boss Crown Bullies per the bill of sale/as discussed and signed by both. Buyer and Breeder.

Before any said litters come into effect; veterinary care must be provided to puppy microchip #\_\_\_\_\_. Certificate must be provided to Boss Crown Bullies with current updated vaccinations, including Bordetella (kennel cough) and a clear Brucellosis test.

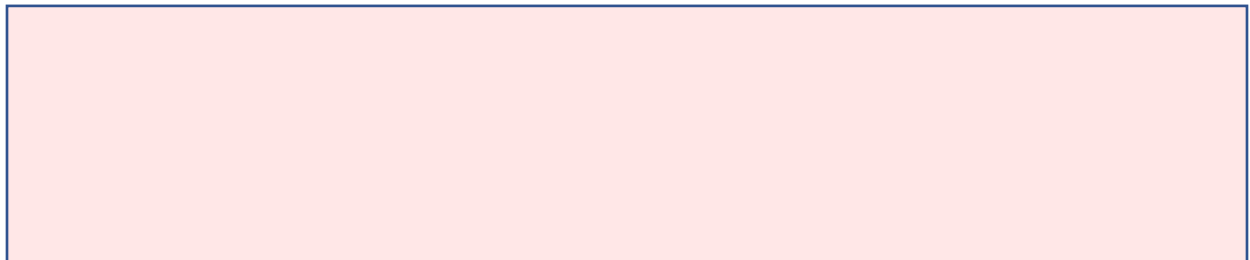
When time to breed you must notify Boss Crown Bullies that puppy Microchip # \_\_\_\_\_ is ready and in good health, with certificate of veterinary for proof.

When time to breed you must notify Boss Crown Bullies of stud wanting to use. Stud information must be given to Boss Crown Bullies and await **approval**. Unless stud has been chosen beforehand from Boss Crown Bullies.
